## City/State Backpatch Disclaimer and Indemnify and Hold Harmless Agreement

Due to the possibility of issues that may arise from a member of the Azusa StreetRiders International Motorcycle Ministry, hereinafter referred to as "ASR" in this document, this "Indemnify and Hold Harmless" agreement must be signed by any member who wishes to have his city and state displayed on the lower ribbon of their ASR backpatch.

The potential does exist for the Confederation of Clubs (COC) or a motorcycle club (MC) / riding club (RC) having an issue with a backpatch color or design, however as an actual motorcycle *ministry*, ASR does not fall under the rules in place by the COC, MC's or RC's. The COC is not an international organization and each state or region has their own regulation within their region. This allows for different opinions as to how each COC governs (or has previously governed) in that particular region. The addition of city and state on our backpatch can be viewed as a statement of territory, even though we do not have a bottom rocker, but rather a ribbon, on the bottom of our patch. ASR is a motorcycle ministry, or MM, and should not be held to any standard or rule in place for either a club or support club. We do not wear a three-piece backpatch, nor is the ribbon on the bottom of our patch considered to be a bottom rocker.

As with any situation that can arise that could be confrontational, ASR recommends that if you encounter a potential problem with either an RC/MC or the COC, apologize and remove your cut to diffuse the situation and then assess whether or not to change to a "HEAVENBOUND" ribbon at that time.

Along with our backpatch, any patch produced or displayed by a member of the ASR should be the result of careful consideration as to the color and design in regard to 1% clubs. We should never have a patch or color arrangement that could be mistaken for another group or club. This is why the only patches that have ASR or Azusa StreetRiders on them require an approval from the board before printing or distribution.

The ASR has members and chapters that have great working relationships with many 1% MCs, and the COC in different regions, around the US. To receive respect, we must give respect. The motorcycle community is our first and most valued missionary field, and our relationships must be nourished and guarded for the ASR to be successful in reaching the unsaved of that community. If you encounter a problem with our backpatch in any way, please contact the ASR board as quickly as possible to discuss the issue and solutions.
